Roe v. Wade Anniversary Toolkit 2024

Summary: 51 years ago, the Supreme Court's *Roe v. Wade* decision provided women with the Constitutional right to abortion, finally giving millions of people decision-making power over their heir futures and families. In June of 2022, a new crop of extremist Supreme Court Justices overturned that landmark ruling, triggering new bans on abortion and making the procedure a crime in state after state. On the anniversary of *Roe v. Wade*, we're fighting to restore and expand legal access to abortion, holding accountable the anti-abortion extremists who are denying our rights and risking our health. We're calling out extremist politicians and demanding that we be in charge of our own health and destinies.

- More than a year after the Supreme Court gutted *Roe*, abortion is banned in 14 states. On the anniversary of #RoeVWade's landmark decision, we're fighting to protect and restore abortion rights and access to the millions of people who need it.
- In 2022, after decades of trying, anti-abortion extremists finally saw the overturn of #RoeVWade, empowering GOP-led state legislatures to enact dangerous and depraved #AbortionBans and putting patients' lives at risk.
- In states that have enacted #AbortionBans, patients' are being forced to death's door before they can access necessary and life-saving abortions.
